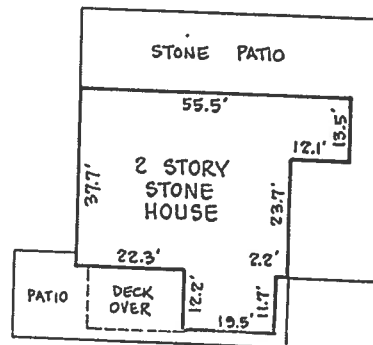


THE BUILDINGS SHOWN ON THIS PLAT

HOUSE LOCATION

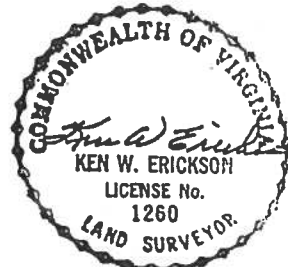

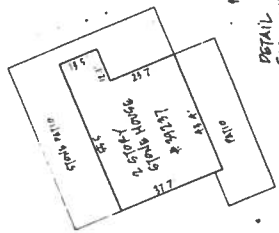
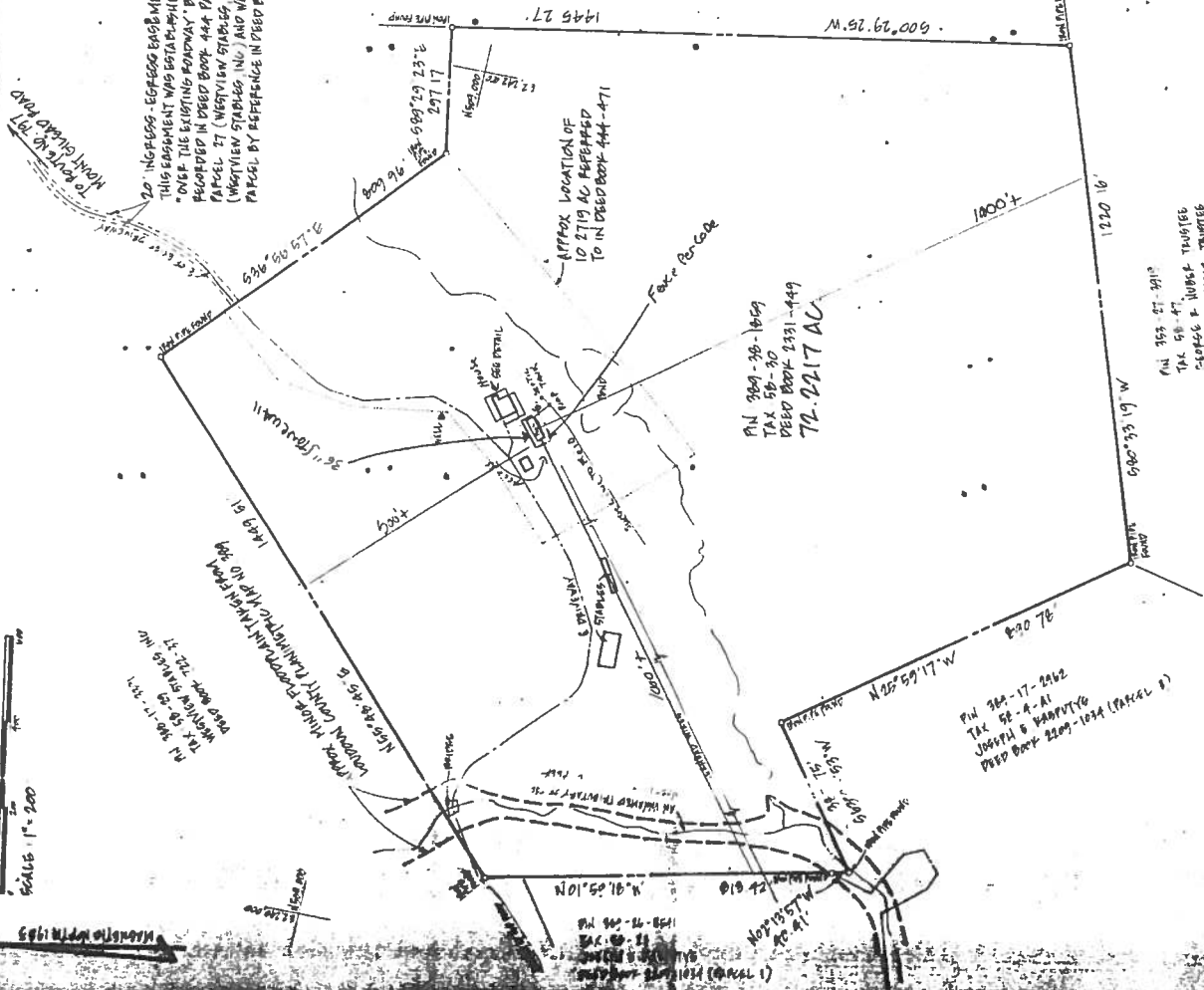
PLAT SHOWING
